The attention of the Regional Directors of School Education, and District Educational Officers in the State is invited to the references 2<sup>nd</sup> & 3<sup>rd</sup> read above, wherein 1450 posts Language Padits Gr II and 1200 posts Physical Education Teachers have been upgraded by the Government. The District-wise allocation of posts as per the sanction accorded by the Government in the reference 2<sup>nd</sup> read above and the criteria adopted for arriving at the number of posts allotted district-wise was also communicated in the reference 4<sup>th</sup> read above. Further, District-wise annexure showing the school-wise details of Language Pandit Gr-II posts upgraded as School Assistant (Languages) and Physical Education Teachers posts upgraded as School Assistant (Physical Education) were also communicated to all the District Educational Officers for taking necessary action as per rules in the matter in the reference 4<sup>th</sup> & 5<sup>th</sup> read above.

Through the reference 11<sup>th</sup> read above, the Govt. has been addressed for issue of clarification regarding filling up of the upgraded posts viz., SA (Lang and Physical Education) and also regarding adjustment of teachers working as LP Gr-II / PETs due to up-gradation of their posts. Clarification from the Govt. is awaited.

Meanwhile, subject to the clarification from the Govt. the following instructions are issued with regard to filling up of the posts upgraded as SAs (Language) and SAs (Phy. Edn.)

- i) Government upgraded posts only to an extent (not persons) 1450 posts of Language Pandits Gr-I & 1200 posts of PETs in G.O. 2<sup>nd</sup> read above.

- ii) Promotions to the posts of School Assistant (Language) / School Assistant (Phy. Edn.) shall be as per the seniority and other eligible factors (no disciplinary case pending etc.) to hold the said posts.
- iii) The teachers, who are working in the posts which are upgraded, shall have to vacate their places due to filling up of the posts in view of up-gradation of posts and such LP Gr-II / PETs shall be adjusted in the vacancies arising due to promotions in the existing vacancies on administrative reasons.
- iv) The adjustment of such teachers shall be strictly as per rules through counseling system.
- v) The filling up of the posts shall be as per ratio (Promotion) 70:30 (Direct Recruitment) as per rules.
- vi) District Educational Officers should ensure / re-confirm availability of posts upgraded in respective schools.
- vii) The above exercise shall be undertaken immediately in the four (4) districts (East Godavari, West Godavari, Krishna & Guntur) where there is no election code. Compliance should be submitted by 20.2.2017
- viii) In the 9 districts where the election code is in force, the promotions by counseling exercise may be undertaken after the lifting of the code and compliance submitted by 25.3.2017.

The District Educational Officers are also requested to take necessary immediate action in the matter as per existing rules and submit compliance report promptly.
