Sanction of conveyance allowance to the hearing impaired employees as per
the recommendations of 10th Pay Revision Commission – Orders – Issued.

ORDER:

In the reference 1st read above, the Hon'ble Supreme Court of India,
in its directions dt.12.12.2013 in W.P.(Civil) No.107, of 2011 has directed as
follows:

*".....direct the respondents to grant transport allowance
to deaf and dumb persons also on par with blinds and
orthopaedically handicapped employees of Central and the
State Governments and other establishments wherever
such benefits have been extended to the blinds and
orthopaedically handicapped employees. Ordered
accordingly.*

2. The 10th Pay Revision Commission has also recommended for
sanction of conveyance allowance to hearing impaired employees, the
recommendation of the Commission is as follows:

*" 11.115. So far Conveyance Allowance was allowed to
only blind and physically handicapped employees,
several associations have represented that this allowance
should be extended to hearing impaired employees
also. This Commission has accepted this request and
recommended payment of this allowance to hearing
impaired employees as well the Commission also
recommends for an increase in this allowance to 10% of
basic pay subject to a maximum ceiling of Rs.2000/-
per month".*

3. Based on the recommendations of the 10th Pay Revision Commission,
in the reference 2nd read above, the Finance (HR.VI, TFR, A&L -TA)
Department, have issued orders, for sanction of Conveyance Allowance to
the Blind and Physically Handicapped employees only @ of 10% of the basic
pay subject to a maximum ceiling of Rs.1350/- per month, with effect from
1.12.2015.

4. In the reference 3rd read above, the State President, Andhra Pradesh
Hearing Handicapped Employees Association, has represented that
conveyance allowance to hearing impaired employees is not being sanctioned
by the respective departments even after the 10th Pay Revision Commission
recommended for the same in their report. He has further stated that in the
Revised Pay Scales 2010, the conveyance allowance has been sanctioned to
the hearing impaired employees. He has also stated that , the Hon'ble

Supreme Court in Writ Petition (Civil) No.107/2011, dt.12.12.2013 directed the respondents to grant transport allowance to deaf and dumb persons also on par with blind and orthopaedically handicapped employees of Central and the State Government and other establishments. Therefore, he has requested to address the Government for payment of conveyance allowance to deaf and dumb employees on par with blind and physically handicapped employees.

5. Government after careful examination of the matter and keeping in view of the recommendations of the 10th Pay Revision Commission and also as per the directions of the Hon'ble Supreme Court in Writ Petition (Civil) No.107/2011, dt.12.12.2013, hereby decided to sanction of conveyance allowance to the hearing impaired employees on par with the blind and physically handicapped employees @ 10% of the basic pay subject to a maximum ceiling of Rs.1350/- per month.

6. Accordingly, Government hereby sanction conveyance allowance to the hearing impaired employees on par with the blind and physically handicapped employees, @ 10% of the basic pay subject to a maximum ceiling of Rs.1350/- per month, prospectively with effect from the date of issue of the G.O.

7. The Director, Welfare of Differently Abled & Senior Citizens, Vijayawada, Andhra Pradesh, shall take necessary action in the matter accordingly.

8. This order issues with the concurrence of the Finance (HR.VI-A&L-TA-MSPA) Department vide their U.O.No.25029/24/2016, dt.26.04.2017 and 11.07.2017.
