**GUIDELINES FOR SELECTION OF SECTORAL OFFICERS IN THE DISTRICT PROJECT OFFICES, SSA DURING THE YEAR - 2019**

1. Application in the prescribed format are invited for the post of Sectoral Officers on Deputation under Foreign Service Terms and Conditions at District Project Offices, Sarva Shiksha Abhiyan.
2. Gazetted teachers of School Education Department of Andhra Pradesh are eligible to apply. Applications should be submitted in the respective District Project Offices, Sarva Shiksha Abhiyan in which the Gazetted teacher is working.
3. Candidates should apply through proper channel only.
4. Candidates should apply for more than one post in one application.
5. Age of the candidates shall be below 50 as on the notification issued.
6. No applicant can claim right for deputation to SSA based on this notification.
7. The antecedents of the individual, previous experiences, track record, etc will also taken into consideration for deputation.
8. The state Project Director may consider or reject the application.
9. The candidates who have worked in SSA on deputation for a period of five (05) years continuously or in different spells are not eligible to apply for the post of Sectoral Officers in SSA.
10. 85 marks weightage shall be given for Academic and Professional qualifications and oral interview will be considered 15 marks for selection of Sectoral Officers.
11. The weightage shall be provided as shown in the following table.

12. The Weight age for the Academic and Professional Qualification should be calculated based on the percentage of marks secured. For example, if a candidate secures 640/1000 marks in degree. The weightage of marks shall be 6.4.

13. Similarly, marks should be given for the number of years of service rendered in the cadre of Headmaster ie., 2 marks for each completed year of service.

**1. GENERAL INSTRUCTIONS:**

- (i) Applications for the post of Sectoral Officers should be submitted in the respective District Project Offices, Rajiv Vidya Mission (SSA) where the candidate is working. If application is submitted in other districts shall be rejected.
- (ii) In-service candidates should invariably apply through proper channel. Applications submitted directly without proper channel will be summarily rejected.
- (iii) Candidates can apply for more than one post in one application only.
- (iv) Age of the candidates shall be **50 years** below **as on 01.05.2013**
- (v) The candidates shall have rendered **atleast 10 years of service** in Government sector to the said above date
- (vi) The selected candidates shall work for a minimum period of 2 years in the project. In this regard they should have give undertaking. The candidate shall report to duty within 15 days from the date of receipt of deputation order. Otherwise, they will forego their candidature to join in the project and action will be initiated against such candidates as per CCA Rules.
