NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Government of Andhra Pradesh hereby makes the following amendment to Andhra Pradesh Revised Scales of Pay Rules, 2022.

AMENDMENT

The following rule shall be inserted after Rule 7.

"7-A. In the event of stagnation, five stagnation increments shall be allowed beyond the time scale in the Revised Scales of Pay, 2022. These stagnation increments shall be treated as regular increments for all purposes such as fixation of pay on promotion /Automatic Advancement Scheme, Pension etc."
