With reference to your letter 4th cited, I am to inform that at para 7 of GO 1st cited, Government have issued orders clearly specifying the sanction powers regarding Medical reimbursement claims to the Dist officers and HoDs. At para 2(h) of the G.O 2nd cited Govt have issued orders increasing the scrutiny limit of Rs 25000/- to Rs 50000/- to Dist Hospital Supdt/Superintendents of Teaching Hospitals and delegation of powers of Medical Reimbursement upto Rs 50000/- to the Dist Level Officers.

But in the reference 3rd cited orders have only issued delegating the powers of only to draw claims of Medical advance/Medical reimbursement to Dy DEOs/MEOs/H.Ms after scrutiny of Dr.YSR Aarogyasri Health care trust, AP, at para 7.3 vii, 7.4 viii & 7.5 viii respectively, but **not the sanctioning powers.** Clarification was already issued vide reference 5th cited to the president, AP United Teachers Federation in this matter (copy enclosed).

In view of the above position the delegation of sanction powers to the DDOs of the School Education Department requires specific Government orders with Finance concurrence.
