ORDER :-

In the G.O first read above, Government issued orders that any Indian Citizen / NRI who comes forward to donate any asset i.e. either land/ building/money worth about Rs.5.00 lakhs for a Primary School, Rs.7.5 lakhs for an Upper Primary School and Rs.10.00 lakhs for a High School or will have the asset named in his/her name or in any name proposed by him, provided that such name was acceptable to Government. In the G.O second read above, certain amendments were issued to the G.O first cited that the amount donated less than Rs. 5.00 lakhs are also welcome, and the amount was donated for the specific purpose of construction of a class Room/ building, only that class Room/ building shall be named after the donor as already stipulated in the G.O. first read above.

2. The government has launched Naadu-Nedu program to facilitate robust infrastructure facilities in Education and Health sectors. The programme primarily focuses on upgrading/ improving existing physical infrastructure in all government schools and hospitals in a period of 3 years. To successfully complete such a huge initiative, it requires participation of people/organizations outside the Government. The earlier orders of the Government covers only Government school and not Hospitals.

3. After careful examination of the facts and circumstances stated above, Government hereby decided to Name the Institutions (Schools & Hospitals) after the donors' with certain norms and conditions as detailed below:-

(a). The eligibility norms for donors to get naming rights for entire school/hospital :-

School/Hospital	Type of building	Donations to be made
School	Satellite Foundation School	Rs. 50 lakhs
	Primary school	Rs. 100 lakhs
	High School	Rs. 300 lakhs
Hospital	Primary Health Centre	Rs. 100 lakhs
	Community Health Centre	Rs. 500 lakhs
	Area Hospital	Rs. 1000 lakhs

(b). Indicative norms for naming institutions after donors

- (i). Naming the entire school, doesn't bar/prohibit the government to give permission to other donors to donate and get the naming rights for the individual blocks/buildings inside the school/ hospital premises
 - (ii). The donor who bears 100% cost of construction of a block within a public institution (for ex. Additional class room/library block in a new Engineering College/Medical College, Digital Library in a Village etc.), then the individual block is to be named after the donor.
 - (iii). The naming rights of the donor is maximum for a period of 20 years
 - (iv). Final approval will be given by the Government.
4. The School Education/ HM & FW / PR & RD Departments shall take necessary further action in the matter accordingly.
